## JCRA Highlights Licensing Requirements of the Postal Services (Jersey) Law 2004

The Jersey Competition Regulatory Authority ("JCRA") would like to remind businesses potentially engaged in the provision of postal services in Jersey of the requirements of the Postal Services (Jersey) Law 2004 ("the Law").

The main purpose of the Law, which came fully into effect on 1 July 2006, is to abolish the exclusive privilege of the States of Jersey in postal services and to empower the JCRA to licence other postal operators in Jersey where appropriate.

The Law requires persons or businesses who are conveying letters from one place to another to hold a licence authorizing them to do so, so long as the letters fall into the so-called "licensable area". The licensable area is where the consideration for the conveyance and delivery of the letters is the payment of £1.30 or less (per letter) and where the weight of each letter does not exceed 500 grams. Operating a postal service within these limits without a licence is illegal, which may be punishable by fines or imprisonment. However, the conveyance and delivery of certain items are exempt from the Law which includes books, catalogues, newspapers, periodicals and banking instruments. In addition, there are other specific exemptions to the licensable area set out in the Law, which may apply in particular circumstances.<sup>1</sup>
