**Proposed Determination regarding
Jersey Post Limited's Price Control**

22 November 2011

**Determination under Condition 20.3 of Jersey Post Limited's Licence
issued by the Jersey Competition Regulatory Authority to:**

Jersey Post Limited

Condition 20.3 of the licence issued to Jersey Post Limited ('Jersey Post') on 1 July 2006 (the 'Licence') allows the Jersey Competition Regulatory Authority ('JCRA') to determine the maximum level of charges that Jersey Post may apply for Licensed Services or Postal Services to fulfil the Universal Service Obligation ('USO').

Whereas:

- There is considerable uncertainty regarding the volumes of mail that will be carried by Jersey Post in 2012, in particular as a result of announced changes to low value consignment relief for import of goods into the United Kingdom from the Channel Islands;
- Jersey Post remains the sole provider of many categories of Licensed Services and Postal Services to fulfil the USO in Jersey;
- The JCRA believes that it would be prudent to protect postal users in Jersey from very large increases in prices by Jersey Post;
- The JCRA has therefore decided to maintain the price control determination that currently applies to Jersey Post, for a further 12 months until 31 December 2012, with appropriate modifications.

The JCRA hereby determines as follows:

1. The JCRA will cap the maximum level of charges that Jersey Post may apply for Licensed Services or Postal Services to fulfil the USO (the 'price control') in the manner set out in this Determination.
2. The scope of the price control shall be limited to the services listed in Annex 1 of this Determination, and any new services introduced by Jersey Post that do or can compete with the services listed in Annex 1 ("Price Controlled Services").
3. Any reference in this Determination to "year" shall be read as a reference to a calendar year.
4. Unless otherwise indicated, defined terms herein shall have the meaning ascribed to them in the *Postal Services (Jersey) Law 2004* (the 'Law').
5. The "price control period" shall run from 1 January 2012 to 31 December 2012.
6. "Actual Revenue" means the amount of revenue that has actually been collected by

Jersey Post through the provision of Price Controlled Services during the price control period.

7. “Allowed Revenue” for the price control period (i.e. ‘year T’) shall be the sum, over all Price Controlled Services (i), of the base price P_T multiplied by the actual volume for that service in year T (V_T), such that:

$$\sum i(P_{i2012}V_{i2012}) = \text{£}12,316,990 \times (100\% + (RPI_{2012} - X))$$

where:

i = the range of Price Controlled Services

P_{i2012} = price for Price Controlled Service i as at 1 January 2012

V_{i2012} = the actual volume for Price Controlled Service i in the year 2012

X is determined as 1.8

RPI_{2012} is determined as the percentage change in the value of the RPI series produced by the States of Jersey Statistics Unit between June 2010 and June 2011

8. Jersey Post shall set prices for Price Controlled Services so that the Actual Revenue does not exceed the Allowed Revenue.
9. An Automatic Volume Adjustment (AVA) shall apply to the calculation of Allowed Revenue in the event that the total volume of Price Controlled Services deviates by at least 5 per cent from 14,626,756 (ie the 2011 volume of 16,251,951 x 0.90, incorporating an assumption of a decrease in volumes of 10% over 2012), being the total volume forecast for the price control period. If total volumes are more than 5 per cent lower than forecast, Allowed Revenue will be decreased by a percentage amount equivalent to half the difference between the percentage reduction in volumes below forecast and 5 per cent. This reflects the assumption that on average 50 per cent of costs are fixed and 50 per cent are variable. Similarly, if total volumes are more than 5 per cent higher than forecast, then Allowed Revenue will be increased by a percentage amount equivalent to half the difference between the percentage increase in volumes above forecast and 5 per cent.
10. For the avoidance of doubt, Jersey Post is allowed to increase prices for individual services in Annex 1 by more than RPI-X, subject to Licence Conditions 20.2 and 20.4. This does not preclude recourse by the JCRA to Licence Condition 20.5. It should be noted that Article 16 of the *Competition (Jersey) Law 2005*, which prevents an undertaking which is dominant in the supply of a service from abusing its dominance by charging an excessive price for that service, might also apply.
11. The X factor has been calculated on the basis of an allowed 3 per cent profit margin on operating and capital expenditure associated with the provision of the Price Controlled Services and a fair share of the operating losses on Jersey Post’s retail business unit. The actual profit margin earned by Jersey Post is neither restricted nor guaranteed. If Jersey Post achieves cost reductions that exceed those assumed feasible and forming the basis for the X factor, its profit margin, *ceteris paribus*, will exceed the 3 percent profit margin

that has been allowed. The converse also applies.

12. In the event of unforeseen events which occur during the price control period and which are accepted by the JCRA as being outside Jersey Post's control, Jersey Post may apply to the JCRA for a revision of this Determination.
13. By 31 March 2013, Jersey Post shall provide a written report to the JCRA, in a form agreed by the JCRA, on its compliance with this Determination.
14. This Determination shall come into effect on 1 January 2012, or such later date as is specified in a Final Notice issued by the JCRA.
