1. Introduction

1.1 The Channel Islands Competition and Regulatory Authorities (**CICRA**) has carried out a review of its strategic priorities which has then gone on to inform the development of its draft 2018 work programme.

1.2 From this CICRA has sought to take account of likely market developments beyond the short term. Policy ambitions and development across sectors where CICRA is the economic regulator or competition law enforcement body has also informed this process and will continue to do so. As CICRA has a role in a number of sectors as an economic regulator, as well as a law enforcement body, only some of its areas of work will be of interest to potential respondents.
